**TERMS AND CONDITIONS p.2**

- \_\_\_\_\_ **1. PAYMENT:** A \$400.00 deposit is required to secure the date of your tournament. The deposit will be applied to your final bill. Full payment is due the day of the event. It is the tournament chairperson's responsibility to collect green fees, cart fees, and food service fees.
- \_\_\_\_\_ **2. PLAYERS:** All players are required to ride in carts. Players must acknowledge standard golf course rules and accept responsibility for course and cart damage. Children not listed as players Will not be allowed on the golf course, but are welcome to attend functions prior to and following the tournament.
- \_\_\_\_\_ **3. BEVERAGES: GLOCESTER COUNTRY CLUB** has a BYOB policy for alcoholic beverages. It is the tournament director's responsibility that NO ONE under legal age will consume alcoholic beverages on GLOCESTER CC PROPERTY.
- \_\_\_\_\_ **4. FOOD SERVICES:** A confirmation of the number of players is required 10 days prior to the event. This guaranteed count **may not be reduced**, but can be increased by 10%. You will be charged on your guaranteed count or the actual count, whichever is greater.
- \_\_\_\_\_ **5. PROPERTY:** All items brought in by the tournament chairperson and/or guests must be removed at the conclusion of the event. Gloucester Country Club is not responsible for any loss or damage to your property during the event.
- \_\_\_\_\_ **6. CANCELLATION:** This event may be cancelled upon written notice from the tournament chairperson. In the event the tournament is cancelled within fifteen (15) days of event, the \$400.00 deposit will **not** be refunded.
- \_\_\_\_\_ **7. INDEMNIFICATION:** To the extent permitted by law, you agree to protect, indemnify, defend and hold harmless GLOCESTER COUNTRY CLUB and and its respective employees and agents against all claims, losses, or damages to persons or properties, government charges or fine, and costs (including reasonable attorney fees), arising out of or connected with your function, except those claims arising out of the sole negligence or willful misconduct of the golf course. The parties agree in the event that any dispute arises in any way relating to or arising out of this contract, the prevailing party in any arbitration or court proceeding will be entitled to recover an award of its reasonable attorney's fees and costs.
