RESTRICTIONS:

1. **ALL MEMBERS SHALL BE SUBJECT TO AND AGREE TO THE GLOCESTER COUNTRY CLUB CODE OF CONDUCT.**
2. Memberships are yearly memberships and run January 1 to December 31 for any given calendar year.
3. GCC has the right to limit the number of members for any of the Membership Levels.
4. Check with Pro Shop for Guest Rates and time restrictions.
5. Assessments, Dining Minimums, RIGA, Locker, Bag Storage and Dock Rentals are not included in Annual Dues and will be invoiced separately. Storage of a second golf bag will be at 50%.
6. Lockers, Bag Storage, and Dock Rentals are subject to availability.
7. Guest privileges limited to a maximum of 3 guest per round. An individual may only play as a guest a maximum of four (4) times per month.
8. Family B and Senior B Members may not play before 10:30 am.
9. Junior Memberships are for individuals, not included in a family membership, between the ages of 12 to eighteen (18) years of age or up to age twenty-three 23 **AND** attending school or college full time.
10. Beach and Dining Members Golf Privileges limited to once a month, per family, with restrictions; guest fees apply.
 - i. Guest fees will apply for Beach & Dining Members.
 - ii. Beach & Dining Members may NOT bring guests for golf.
11. Introductory Members approved prior to 2022 shall increase to the next level as stated above.
 - i. Full Membership will be in year 5.
 - ii. Tournament play is allowed.
12. Annual dues for all Membership Levels to be paid in five (5) monthly payments, January to May or as determined by the Treasurer and approved by the Board. Invoices will be issued via e-mail on the 1st of the month and are due no later than the 15th of the month.
 - i. Failure to make timely payments may result in suspension.
 - ii. Dining Minimums to be invoiced monthly, May to September.
13. Unlimited Cart Plans are available. Check with a GCC Board Member for rates and availability.
14. League and Tournament fees vary and are in addition to membership fees.

Definitions

Partner:

A partner is defined as a member of a domestic partnership which is either a legal or interpersonal relationship between two individuals who live together in the same domicile and share a common domestic life but are neither joined together by marriage or a civil union. Partners are each other's sole domestic partner and intend to remain so indefinitely; maintain a common residence evidenced by a valid voter registration, driver's license, or vehicle registration; and share responsibility for a significant measure of each other's financial obligations.

Immediate Family:

A member's immediate family shall be their spouse or partner, child and or stepchild under the age 26, attending school or college and are considered as a dependent of the member.
