GLOCESTER COUNTRY CLUB GROVE AND PICNIC GUIDELINES

The following guidelines and procedures pertaining to the effective operation of the Glocester Country Club (GCC) are issued for the benefit of all members. In recent years at GCC it has become apparent that, with an influx of new members, procedures and practices must be re-evaluated for applicability today. The Board recognizes the heterogeneity of our membership and the variety of interests which need to be accommodated. These procedures attempt to be responsive to the wide range of interests of our membership. For members, their families, and guests to derive maximum enjoyment and pleasure from our Club, the Board requests everyone's cooperation in complying with these rules. However, it is impossible to address every contingency. In most cases using common sense and respecting the rights of other members will suffice. These procedures may be changed from time-to-time by the Board. Any questions may be referred to any member of the Board.

A. Grove Guests

- 1) All members and their immediate families have access to the grove.
- 2) Members may bring up to 8 adult guests without gaining Board approval.
- 3) Parties including 9 or more adult guests <u>must</u> be approved by the Board.
- 4) Members must sign-in at the Boat House and include the number of guests attending.
- 5) Members will be charged a fee of \$5 per guest.
- Board Approved parties of 9 or more will be subject to rental fees. Parties of 9 or more may also be subject to additional fees as the Board deems necessary including but not limited to Port-o-Potty emptying and general trash & clean-up. Individual requests by members to rent the facilities will be evaluated by the Board on a case-by-case basis. Consideration will be given based on criteria such as size of the party and degree of inconvenience to the general membership.

- **B.** Children Children under the age of twelve (12) must be attended by an adult when using GCC facilities. (See Article IX Guidelines for Juniors).
- **C.** Pets Animals of any kind are not allowed on GCC property.
- **D.** GCC is a family-oriented club relying on the efforts of the Board and the general membership to manage the Club's affairs. It is important to recognize the limitations of a 9-hole course and the sometimes-conflicting demands of no tee times, golf tournaments, leagues...etc. Cooperation is essential.
- **E.** The PGA Golf Professional is charged by the Board with responsibility and authority for managing golf play in accordance with these procedures.
- **F.** Grove facility includes: Changing Rooms, Outdoor Shower, and Port-o-Potty. Members and guests are expected to utilize these facilities when enjoying the beach and picnic grove areas.
- G. GROVE & PICNIC AREA ATTENDEES ARE NOT ALLOWED TO USE RESTROOMS IN MEMBER LOCKER ROOMS OR CLUB HOUSE. NO BEACH ATTIRE IS ALLOWED PAST THE DRIVEWAY ADJACENT TO CLUB HOUSE.
- **H.** When ordering or picking up food, Members/Guests <u>MUST</u> wear proper attire and access the kitchen from the upper deck area near the pro shop.
- I. The Grove Committee will be monitoring the area frequently and are authorized to request people violating the rules to vacate the area.
