	At the beginning of each calendar year, the family shall designate one "A" Member. The "A" Member's spouse or domestic partner and dependent family members shall be considered "B" members. The "A" Member shall have unlimited golf privileges. The "B" member and dependent children under the age of 26 shall have golf privileges with restrictions as defined below and in the Membership Levels. All family members will have access and use of club facilities. * A Family AB Membership shall receive a \$25 Proshop Credit upon full payment of the Annual Dues. Restrictions: 1. Family members 16 years of age or older included in a Family AB membership shall not be allowed to golf before 10:30 am weekends and holidays. Check-in with the Pro Shop required. If a tournament is not full within 2 days of the event, and at the discretion of the Pro, "B" Members at least 16 years of age may be allowed to play in said tournament. 2. Family members under the age of 16 shall not be allowed to golf before 12:30 on weekends and holidays except at the discretion of the Pro. Family members under the age of 12 must be accompanied by a parent. Tournament play will not be allowed.

Golf privileges include four (4) rounds of golf per month, with green fees waived for one (1) round, while the remaining three (3) require payment of green fees. Cart fees, if applicable, must also be paid, and members have unlimited access to the driving range and putting green. If a tournament is not fully booked, the Golf Committee will notify social members via email two (2) days prior, inviting them to participate, though members cannot act as substitutes in any league. Guest privileges allow members to bring guests for dining, social events, or golf at guest rates. 	Any individual or Family Member having been a member in good standing for not less than 15 years may request a Senior Membership upon reaching the age of 65 and retirement may request a change in Membership Level to Senior Individual or Senior Family if <u>BOTH</u> are retired and have reached the age of 65. Senior Memberships shall require a favorable vote by the current Board of Directors, whose decision is discretionary. Prior to granting a Senior Membership, the Board should, at a minimum, consider the following: 1. Overall membership: The total of all other golf membership levels should be no less than 150 (85%) of the 175 total allowable Golf Memberships. 2. Longevity: Total number of consecutive years as a GCC Member. 3. Contributions to GCC, such as, but not limited to: Years served on GCC Boards and committees. Donation of time and other contributions to GCC. 4. The board may consider any other information provided relevant to the request for Senior Membership. Senior Memberships shall be limited to a total of 15. * A Senior Membership shall receive a \$25 Proshop Credit upon full payment of the Annual Dues.

	Any Existing Member, having been a member having been in good standing for not less than 25 years and 72 years of age is eligible for nomination to a Life Membership. The Nomination shall be submitted in writing to the Board of Governors by any current member for review and consideration. The Board of Governors may elect to grant a Life Membership for reasons judge worthy by the Board of Directors, whose decision is discretionary. Lifetime Members do not have golfing privileges but may enjoy the use of the course as a guest of a member. A Lifetime Member shall pay all applicable guest rates and cart fees for each round of golf. If a tournament is not full within 2 days of the event, and at the discretion of the Pro, a Lifetime Member may be permitted to play in said tournament. Prior to granting a Lifetime Membership, the Board shall consider the following: 1. Overall membership: GCC golfing memberships must be full (Full golfing membership means there are a total of 175 active golfing memberships.) 2. A new member is available to fill the golfing membership left open by the Lifetime Membership being considered. 3. Longevity: Total number of consecutive years as a GCC Member. 4. Contributions to GCC such as: Years served on GCC Boards and committees. Donation of time and other contributions to GCC. 5. The board may consider any other information provided relevant to the request for Senior Membership. Generally, the Board will not elect Full Members to a Lifetime status unless there are applicants available to fill the open membership position. Lifetime Memberships shall not be included in the total number of golf memberships.

RESTRICTIONS:

1. ALL APPLICANTS AND OR MEMBERS SHALL BE SUBJECT TO AND AGREE TO THE GLOCESTER COUNTRY CLUB CODE OF CONDUCT.
2. ALL APPLICANTS AND OR MEMBERS SHALL BE SUBJECT TO AND AGREE TO ABIDE TO THE GCC BYLAWS AS WRITTEN AND ACCEPTED BY THE MEMBERSHIP.
3. ALL APPLICANTS AND OR MEMBERS SHALL BE SUBJECT TO AND AGREE TO ABIDE TO THE GCC GUIDELINES AS WRITTEN AND ACCEPTED BY THE MEMBERSHIP.
4. A FAMILY MEMBERSHIP shall mean one adult member, their spouse or domestic partner and all dependent children under the age of 26.
5. Memberships are yearly memberships and run January 1 to December 31 for any given calendar year.
6. Annual dues for all Membership Levels to be paid in five (5) monthly payments, January to May. Invoices will be issued via e-mail on the 1st of the month and are due no later than the 15th of the month.
 - a. Dining Minimums to be invoiced monthly, May to September.
 - b. Failure to make timely payments may result in suspension and late payment fees.
 - c. Annual dues and Assessments are non-refundable.
 - d. All dues paid in full by May 31.
7. Assessments, Dining Minimums, RIGA, Locker, Bag Storage and Dock Rentals are not included in Annual Dues and will be invoiced separately. Additional fees are required for more than 1 bag.
8. Lockers, Bag Storage, and Dock Rentals are subject to availability.
9. GCC has the right to limit the number of members for any of the Membership Levels.
10. Check with Pro Shop for Guest Rates and time restrictions.
11. An individual may only play as a guest a maximum of 4 9-hole rounds or 36 holes per month.
12. A member may have a maximum of 3 guests per round.
13. Family B and Senior B Members may not play before 10:30 am.
14. Junior Memberships are for individuals, not included in a family membership, between the ages of 12 to eighteen (18) years of age.
15. Beach and Dining Members may play golf as stated below:

- a. As a guest of a current member a maximum of 36 holes per month. Guest fees apply.
- b. Beach & Dining Members may not bring guests for golf.

16. Unlimited Cart Plans are available. Check with a GCC Board Member for rates and availability.

17. League and Tournament fees vary and are in addition to membership fees.

Definitions

Partner:

A partner is defined as a member of a domestic partnership which is either a legal or interpersonal relationship between two individuals who live together in the same domicile and share a common domestic life but are neither joined together by marriage or a civil union. Partners are each other's sole domestic partner and intend to remain so indefinitely; maintain a common residence evidenced by a valid voter registration, driver's license, or vehicle registration; and share responsibility for a significant measure of each other's financial obligations.

Immediate Family:

A member's immediate family shall be their spouse or partner, child and or stepchild under the age 26, attending school or college and are considered as a dependent of the member.

Guest Policy:

1. Guest Limits by Time and Day
 - a. Valid anytime during the week or after 10:30 on Weekends.
 - b. Exceptions may be made at the Pro's discretion.
 - c. Additional exceptions require the Board of Governors' authorization.
2. Guest Registration
 - a. All guests must register at the Pro Shop.
 - b. Registration must be verified by the sponsoring member.
3. Member Responsibility
 - a. The sponsoring member must accompany the guest at all times.

- b. The member is responsible for the conduct of their guest(s).
 - c. Members are expected to ensure guests follow the club dress code.
4. Former Members in Arrears
- a. Former members not in good standing (i.e., with unpaid balances) are not permitted to play as guests.
 - b. After full payment of outstanding dues, a penalty period applies:
 - i. The former member will be prohibited from playing as a guest for a duration equal to the number of days their balance was more than 30 days overdue.
 - ii. The penalty is enforced during the April 1 – October 31 period.
 - iii. Example: If dues were unpaid from 11/1/25 to 2/1/26 (92 days), the guest restriction would apply from 4/1/26 to 6/30/26.
5. Monthly Guest Limits
- a. A guest may play a maximum of four (4) times per month, regardless of who sponsors them; for example, if member A brings a guest four times in a given month, that same guest may not be brought out again by member B, during that same month.
 - i. A guest cannot be someone else's guest
 - ii. During each of these four visits, guests may play multiple rounds in a single day.
 - b. Green and cart fees will apply per 9-hole round played.
 - c. Tournaments that allow guests do not count toward the monthly limit.
6. Off-Season Guest Policy
- a. No guests are allowed between December 1st and April 1st, unless the Pro Shop is open to collect guest fees.
